Markings: All markings must be permanent and visible after installation.

1. QAI label with 'C' identifier (item 1097 – black lettering with silver background) is normally located in close proximity to the electrical panel and includes:

- Certification label serial number
- QAI certification logo with the “C” Identifier
- “Permanent Engineered Structures”

2. The specification nameplate (item 1068, 8-1/2” x 14” size) is located in close proximity to the electrical panel and includes:

- Manufacturer’s Name and Address
- Date of Manufacture



- Model Serial Number or Product Code
- Foundation Type (Perimeter Foundation Wall or Piers)
- Floor live Load
- Specified Snow Load (1/50)
- Seismic Response  $S_a$  (0.2)
- Hourly Wind Pressure (1/50)
- Envelope Effective Thermal Resistance
- Windows/Doors/Skylights Thermal Characteristics
- Outside Design Temperature (Heat Loss or Heat Gain)
- Factory Installed Appliances
- Site Installed Components, Assemblies, and Systems
- Electrical Systems Voltage, Frequency, and Amperage

3. Other Markings as required by the relevant codes.

Note 3: *The QAI label and specification nameplate are available from QAI and must be applied at the factory.*

Models / Ratings: Engineered Modular Structures under Parts 3, 4, 5 and 6 of Quebec Construction Code, Chapter I - Building. These structures are intended to be used for a single Major Occupancy classified as *Group A, Division 2 – Assembly*. Structures included in this listing are used as classrooms manufactured in multiple modules up to 2-storey configurations.

This certification does not cover completion of barrier-free access. A qualified professional is required to design and validate barrier-free design as per the requirements of the local authority having jurisdiction.

The design of each discipline: architectural, structural, mechanical, and electrical, requires review and approval by professionals registered in the province where the units are intended to be installed.

**Structural:**

Conventional Wood Frame Construction designed within the scope of Part 4 of Quebec Construction Code, Chapter I - Building.

**Electrical Ratings:**

Up to a maximum of 120/208V, 60Hz, 600A and/or 600V, 60Hz, 200A, 1-phase or 3-phase systems.

**Heating and Ventilation:**

Primarily electrical baseboard heaters. Systems may be equipped with air conditioning (electrical only).

**Plumbing:**

Conventional drainage and venting systems to a maximum of 240 hydraulic fixture units.

**Gas Systems:**

None



**Fire Alarm Systems:**

This certification covers factory installed portions of the fire alarm systems. This certification does not cover completion of the and fire alarm systems on site.

The design of the fire alarm systems must be designed by a professional engineer registered in the province in which the building is intended to be installed. Installation and commissioning of these systems must be completed on site by qualified technicians as per the requirements of the local authority having jurisdiction.

**Sprinkler Systems:**
