- a) Manufacturer's name or trademark
- b) QAI Logo with 'C' and 'US' indicators
- c) Model Number of the device
- d) Rated working pressure
- e) Nominal valve size
- f) The direction of water flow through the device
- g) Critical level, optional for all devices except for devices that are incorporated in an outlet tube furnished by the manufacturer
- h) "Deck Mounted" when tested as deck and equipment mounted per section 3.6

All Backflow Preventers shall be legibly and permanently identified with the following:

- a) Manufacturer's name or trademark
- b) QAI Logo with the 'C', 'US', and 'RV' indicators
- c) Part or model number
- d) Pressure Rating in PSI (Relief Valve set Pressure)

The markings shall be either cast, etched, stamped, or engraved on the body of the device or on a corrosion and water resistant label securely attached to the device with a corrosion resistant material.
