 - Specified Snow Load (1/50)
 - Seismic Response $S_a(0.2)$
 - Hourly Wind Pressure (1/50)
 - Envelope Effective Thermal Resistance
 - Windows/Doors/Skylights Thermal Characteristics
 - Outside Design Temperature (Heat Loss or Heat Gain)
 - Factory Installed Appliances

- Site Installed Components, Assemblies, and Systems
- Electrical Systems Voltage, Frequency, and Amperage

Models / Ratings: **The scope of structures covered by this listing include:**

Structures:

Commercial/Industrial structures comprised of single or multiple modules. Commercial/Industrial structures typically include but are not limited to office space, stores, construction camp facilities such as washroom facilities, dormitories, kitchens and dining trailers, equipment buildings, and other similar commercial or industrial buildings.

Electrical Ratings:

120/240V, Single Phase, 60Hz, 200A max and/or 120/208V, 3-Phase, 60Hz, 200A max

The operation of the complete fire alarm system is not included in this report and QAI certification. This report does not include structures for use in hazardous locations. This report does not include services other than the electrical nor does it include vehicular lighting or brake wiring systems.

Structure included in this Listing are manufactured at a central facility, complete with electrical wiring, for installation or connection to other modules in the field. These units, when completely assembled in the field, are equipped with normal facilities for connection to electrical services.
