The specification nameplate (item 1066, white with black, 8-1/2" x 11") is located in close proximity to the electrical panel and includes:

- manufacturer's name and address
- model and serial numbers
- fuel type
- complete electrical rating
- year of manufacture
- appliances and equipment that are factory installed
- additional markings as may be required
- ground and design snow load
- thermal resistance of insulation and design heat loss

Models / Ratings: **Homes:**

Single Family dwelling classified under *Group C Occupancy*, comprised of single or multiple modules up to 3-storey configurations that may be installed on a permanent foundation. These modular homes under this scope have a building area not exceeding 600m<sup>2</sup>.

This product listing does not include duplexes and multi-residential dwelling units requiring separation, nor does it cover commercial/industrial units, apartment buildings, hotels, motels, panelized homes/buildings, or care /custodial facilities.

**Structural:**

Conventional Wood Frame Construction within the limitations of Part 9 of the National Building Code.

**Electrical Ratings:**

120/240V, 60Hz, 200A Max.

**Heating/Ventilation:**

Electric Baseboard Heaters. Modules may be equipped with ducting for installation of a central forced air furnace on site. Manufactured homes may be equipped with air conditioning (electric only).

**Plumbing:**

Conventional drainage and venting systems to a maximum of 180 hydraulic fixture units.

**Gas Systems:**
