Models / Ratings:

Single Family Homes are designed and constructed within the limitations of Part 9 without fire and sound separation. This listing does not include multi-residential buildings such as duplexes and row houses requiring vertical separations, hotels and models, and/or any buildings designed with multiple major occupancies.
