### Models / Ratings:

Engineered Modular Structures under Parts 3, 4, 5 and 6 of the Quebec Construction Code, Chapter I – Building. These structures are intended to be used for a single Major Occupancy classified as *Group A, Division 2 – Assembly*. Structures included in this listing are used as portable classrooms manufactured in single or multiple modules up to 2-storey configurations.

This certification does not cover completion of the spatial separation and the barrier-free access which is to be completed on site under permit. A qualified professional is required to design and validate exposing building faces and barrier-free design as per the requirements of the local authority having jurisdiction.

Vehicular lighting and brake lighting systems must be provided by the transport company and be in compliance with the requirements of the Authority Having Jurisdiction.
