## Structures:

Business Commercial Industrial Structures comprised of single modules complete with electrical wiring. Structures included in this listing typically include but are not limited to office space, stores, construction facilities such as washroom facilities, dormitories, kitchens and dining trailers, equipment buildings, and other similar commercial or industrial buildings.

## **Electrical Ratings:**

Up to a maximum of 120/240V, 60Hz, 100A

The structures for use in hazardous locations are not included in this report and QAI certification. This certification does not cover completion of sprinkler and fire alarm system. This report does not include services other than the electrical nor does it include vehicular lighting or brake wiring systems.

Structures included in this listing are manufactured at a central facility and transported to the site.
