  - Foundation Type (Perimeter Foundation Wall or Piers)
  - Floor live Load
  - Specified Snow Load (1/50)
  - Seismic Response S<sub>a</sub> (0.2)
  - Hourly Wind Pressure (1/50)
  - Envelope Effective Thermal Resistance
  - Windows/Doors/Skylights Thermal Characteristics
  - Outside Design Temperature (Heal Loss or Heat Gain)
  - Factory Installed Appliances
  - Site Installed Components, Assemblies, and Systems
  - Electrical Systems Voltage, Frequency, and Amperage
- 3. Other Markings as required by the relevant codes.

Note 3: The QAI label and specification nameplate are available from QAI and must be applied at the factory.

# Models / Ratings:

Engineered Modular Structures under Parts 3, 4, 5 and 6 of Quebec Construction Code, Chapter I - Building. These structures are intended to be used for a single Major Occupancy classified as *Group A, Division 2 – Assembly*. Structures included in this listing are used as classrooms manufactured in multiple modules one storey configurations.

This certification does not cover completion of barrier-free access. A qualified professional is required to design and validate barrier-free design as per the requirements of the local authority having jurisdiction.

The design of each discipline: architectural, structural, mechanical, and electrical, requires review and approval by professionals registered in the province where the units are intended to be installed.

#### Structural:

Conventional Wood Frame Construction designed within the scope of Part 4 of Quebec Construction Code, Chapter I - Building.

#### **Electrical Ratings:**

Up to a maximum of 120/208V, 60Hz, 200A, 3-phase systems

### **Heating and Ventilation:**

Primarily electrical baseboard heaters. Systems may be equipped with air conditioning (electrical only).

Fire alarm system consists of smoke detectors, exit signs and emergency lighting.

This certification does not cover completion of the Sprinkler and Fire Suppression Systems. The design of these systems must be designed by a professional engineer registered in the province in which the building is intended to be installed. Installation and commissioning of these systems must be completed on site by qualified technicians as per the requirements of the local authority having jurisdiction.
