Models / Ratings: The scope of prefabricated buildings covered in this listing include:

Structures:

Business Commercial Industrial Structures comprised of single modules complete with electrical wiring. Structures included in this listing typically include but are not limited to office space, stores, construction facilities such as washroom facilities, dormitories, kitchens and dining trailers, equipment buildings, and other similar commercial or industrial buildings.

Electrical Ratings:

Up to a maximum of 120/240V, 60Hz, 100A

The structures for use in hazardous locations are not included in this report and QAI certification. This certification does not cover completion of sprinkler and fire alarm system. This report does not include services other than the electrical nor does it include vehicular lighting or brake wiring systems.

Structures included in this listing are manufactured at a central facility and transported to the site. These modules include provisions for on-site interconnections and connection to electrical power supply. QAI certification covers any factory installed electrical services, equipment, and fixtures. QAI certification is intended to obviate the necessity of further inspection by the local regulatory authorities except for site connections to services or to other modules and for site installed features.
